## Resolution reaffirming designation of the Cumberland Area Metropolitan Planning Organization (CAMPO)

WHEREAS, this resolution reaffirms the designation of the Cumberland Area Metropolitan Planning Organization (CAMPO).

WHEREAS, the Board of County Commissioners of Allegany County were designated as the Cumberland Area Metropolitan Planning Organization (CAMPO) as adopted by on April 16, 1982 in CAMPO Resolution 82-8 and subsequently approved by Maryland Governor Harry Hughes on May 17, 1982.

WHEREAS, the CAMPO was designated pursuant to the provisions of the Federal Transit Administration Statute (49 U.S.C.1607) and the Federal Highway Administration Statute (23 U.S.C. 134); and

WHEREAS, nothing in this Resolution shall set aside any existing legal authority or planning function of the participating states, county, or cities with respect to powers and functions provided through enabling legislation and/or executive powers; and

WHEREAS, the CAMPO shall adopt (and amend as required from time to time) Bylaws for conduct of its business, such Bylaws to be consistent with all applicable federal, state, and local laws, and which Bylaws shall provide for a CAMPO to act as the governing body; and

WHEREAS, in addition to the Bylaws a "Prospectus" will be developed which will articulate the objectives, functions, organization and operation of the CAMPO; and

WHEREAS, the CAMPO acting as an agent of the participating parties may receive financial assistance from the United States of America and the State of Maryland, from its constituent local governments, and from private sources; and

WHEREAS, the CAMPO shall serve as the Metropolitan Planning Organization for the area and it shall coordinate its activities with relevant state, metropolitan, county, and non-metropolitan planning agencies; and


WHEREAS, the municipalities of Cumberland and Frostburg shall be notified of any meetings held by CAMPO; and


WHEREAS, input from the municipalities of Cumberland and Frostburg shall be sought prior to any significant planning action being taken by CAMPO.




