ALLEGANY COUNTY COMMISSIONERS

Re: MOU for Emergency Medical Services response into Allegany County, MD

Dear Mr. Eberly;

This agreement between Morgan County, WV and Allegany County, MD shall be signed within ten (10) days of receipt and returned to the Morgan County Commission office to take effect for a period of ninety (90) days, or all services shall cease at midnight on the tenth day.

Morgan County EMS will only be requested to provide Emergency Medical Services (EMS) into Allegany County, MD on a second due basis and for the ALS call types specified below:

Allergic Reactions, with ineffective breathing
Breathing Problems, with ineffective breathing
Burns (scalds) / Explosion (Blast), Person on fire
Cardiac or Respiratory Arrest, Workable arrest / Not Breathing / Hanging /
Uncertain Breathing
Choking, Complete Obstruction / ineffective breathing
Drowning / Near Drowning / Diving / SCUBA Accident, Arrest / Underwater
Electrocution / Lightning, Not breathing or ineffective breathing
Traffic / Transportation Incidents
Unconsciousness / Fainting (Near), Ineffective Breathing

If Morgan County EMS's Western Unit (Medic 7-8) is already on an incident or otherwise unavailable, no resources from Morgan County EMS will be dispatched.

All requests for EMS service in Allegany County, MD will be routed from the Allegany County 911 Center to the Morgan County 911 Center (who is responsible for dispatching Medic 7-8). Typical communications between MCEMS Units and

Allegany County 911 Center will be on our MOR TAC 3.

This notice supersedes any and all previous mutual aid agreements between the Morgan County Commission or Morgan County EMS and any Allegany County agency for EMS response into Allegany County, MD.

This MOU for Mutual Aid into Allegany County agrees with West Virginia Statutory Authority:





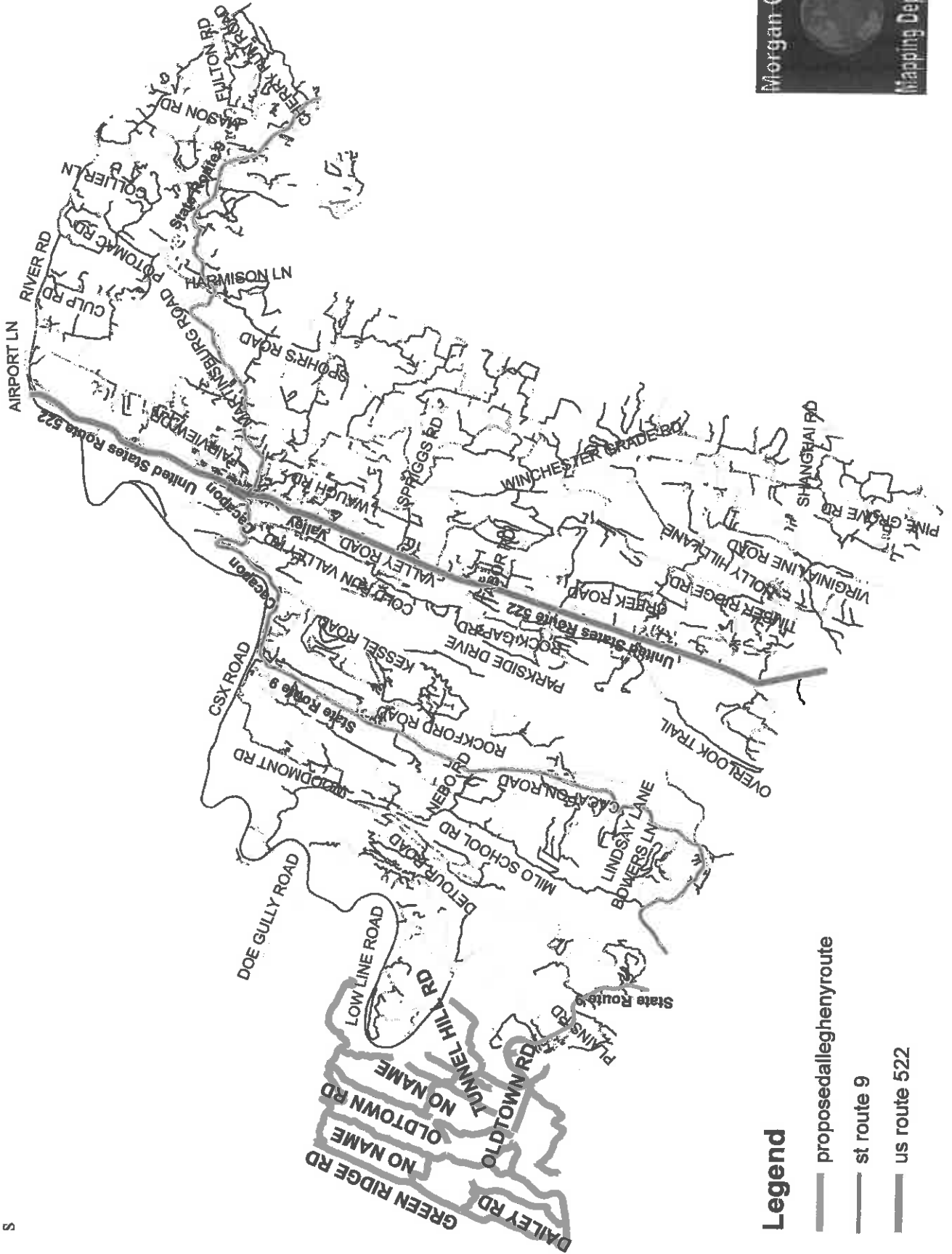
