Subdivision Modifications

- **Currently, Allegany County recognizes two classes of subdivision: “Major” and “Minor”.**
- **There is a separate review and approval process for each class.**

Subdivision Modifications

- **For the most part, review and approval of Minor Subdivision applications are handled administratively by County Development Review staff, under the existing Subdivision Code.**
- **This will continue to be the case under the proposed regulations.**

Subdivision Modifications

- **The existing Subdivision Code defines a Minor Subdivision as consisting of 5 lots or less in non-urban zoning districts ('A' or 'C').**
- **In urban zoning districts ('R', 'G-1', 'G-2', 'B-1', and 'B-2'), the number of lots is determined by the provisions of Article V (Design Standards).**

Subdivision Modifications

- **Under the proposed modifications, there would be two classes of Subdivisions: “Major” and “Minor”.**
- **In addition to having two classes of Subdivision, there will be three types of Minor Subdivision: Type ‘A’, Type ‘B’, and Type ‘C’.**

Minor Subdivision Type 'A'

- **Consists of 5 lots or fewer, regardless of zoning district.**
- **Lot or lots to be created already have roadway access; therefore, no road construction is proposed.**

Minor Subdivision Type 'B'

- **Consists of 5 lots or fewer, regardless of zoning district.**
- **Lot or lots to be created do not have roadway access; therefore, the application will include plans for the proposed roadway that will access the lot or lots.**

Minor Subdivision Type 'C'

- **Consists of 10 lots or fewer, regardless of zoning district.**
- **The lots being created MUST be Clustered.**
- **Lots to be created do not have roadway access; therefore, the application will include plans for the proposed roadway that will access the lots.**

Major Subdivision

- **Major Subdivision will be defined as any subdivision activity which does not conform to Minor Subdivision Types 'A', 'B', or 'C'.**

 - **Submittal must address all staff comments.**
- **Submittal will be forwarded to applicable County, state and regional staff for comment.**
- **Following thorough review by staff, a recommendation (Staff Report) will be forwarded to Planning Commission.**
- **Planning Commission review and approval is required.**

 - **Following a thorough review by staff, a recommendation (Staff Report) will be forwarded to Planning Commission.**

Preliminary Plat Approval (Type 'A')

- **Applicant submits required plans.**
 - **Staff reviews submittals.**
- **Staff approves Preliminary Plat or advises applicant of deficiencies.**
- **In the event that revised submittals are required, items #2 and #3 are repeated.**

Final Plat Approval (Type 'A')

- **Applicant files final submittals.**
 - **Staff reviews.**
- **Staff grants Final Plat approval.**

Comments on Minor (Type 'A')

Process is Streamlined

- **The Sketch Plan phase is eliminated.**
- **No Concept Plan, Site Development or Final Improvement Plans are required.**
- **The approval process by-passes the Planning & Zoning Commission.**
 - **Instead, all approvals are handled administratively at the staff level.**
