You may keep this page

- (1) Grass, leaves, brush and branches, and mixed yard waste generated from landscaping operations.
- (2) Report only that portion that is marketed.
- (3) Includes recycling of wood products (e.g., pallets, crates, barrels, wood furniture, canes, crutches, etc.). Materials must be mulched or composted ONLY. Otherwise, include in "Other (9)" category.
- (4) In order for a material to be classified as an animal protein/solid fat, the material must pass the Paint Filter Liquids Test.
- (5) Refurbished pallets ONLY. List mulched or composted pallets in "Wood Materials" – "Compost/Mulch (Other)" category.
- (6) Tires that are recycled into new products containing rubber (e.g., trashcans, storage containers, rubberized asphalt, etc.), and use of whole tires for playground and reef construction.
- (7) Retread or recapped tires.
- (8) Tires-to-cement kilns. Enter 12% of the total weight of tires used at cement kilns.
- (9) Write in the MRA recyclable material.
